

Period results/Turnover development

bet-at-home.com has grown rapidly in the third period of 2008 . Turnover of the first nine months of 2008 have significantly risen and again reached another all-time record!

Q3 2008:

- Gross Profit/Hold (stakes less winnings):
+ 53,3 % by 9,2 Mio. EUR (Q3 2007: 6,0 Mio. EUR).
- Gaming Turnover:
+ 22,6 % by 151,6 Mio. EUR (Q3 2007: 123,7 Mio. EUR).
- Number of registered users at the end of reporting period Q3 2008:
+ 55,56 % by 1,4 Mio. users (Q3 2007: 0,9 Mio.).

Q1 - Q3 2008:

- Gross Profit/Hold (stakes less winnings):
+ 72 % by 28,2 Mio. EUR (Q1 - Q3 2007: 16,4 Mio. EUR).
- Gaming turnover:
+33,5 % bei 477,8 Mio. EUR (Q1 - Q3 2007: 357,9 Mio. EUR).

In the third quarter of 2008 bet-at-home.com has continued with a double-digit growth. The corporation obtained a gross profit of 9,2 millions EUR, which results to an increase of 53,3% in comparison to the the third quarter of the previous year (6.0 millions EUR).

The first nine months of 2008 ended with a gross profit of 28,2 Mio. EUR. An increase of 72% compared to the first three quarters of 2007 (16,4 Mio. EUR).

bet-at-home.com achieved a gaming turnover of 151,6 Mio. EUR in Q3 2008. In comparison to the similar period in the previous year (Q3 2007: 123,7 Mio. EUR) bet-at-home.com reached an increase of 22,6 %.

As at end of period Q1-Q3 2008 the turnover has risen by 33,5 % to 477,8 Mio. EUR compared to 357,9 Mio. EUR in the period Q1 - Q3 2007.

bet-at-home.com has once again continued with a dynamic increase of customers. The ninth month of 2008 ended with approximately 1.400.000 registered users, an increase of 55,56 % (Q3 2007: Approximately 900.000).
