

bet-at-home.com AG confirms incremental growth

Turnover of the second quarter and of the first term of year 2008 reached a new record level!

Q2 2008:

- Gross yield/Hold (stakes less winnings): +137 % by 10,9 Mio. EUR (Q2 2007: 4,60 Mio. EUR).
- Gaming turnover: + 53 % by 171,9 Mio. EUR (Q2 2007: 112,4 Mio. EUR).
- Number of registered users at the end of reporting period Q2/H1 2008: +65 % by 1,32 Mio. User (Q2 2007: 0,8 Mio.).

H1 2008:

- Gross yield/Hold (stakes less winnings): + 83 % by 19 Mio. EUR (H1 2007: 10,4 Mio. EUR).
- Gaming turnover: +39,3 % by 326,2 Mio. EUR (H1 2007: 234,2 Mio. EUR).

bet-at-home.com set a striking course on incremental growth and achieved a record gross yield of 10,9 Mio. EUR, which is an increase of 137 % compared to the similar period of the previous year (4,6 Mio. EUR). The raise as opposed to Q1 2008 accounted to 35 % (8,1 Mio. EUR).

The first term of 2008 finished at the same time with a gross yield of 19 Mio. EUR. An increase of 83% compared to the first term of 2007 (10,4 Mio. EUR).

bet-at-home.com achieved a gaming turnover of 171,9 Mio. EUR in Q2 2008. As opposed to the similar period in the previous year (Q2 2007: 112,4 Mio. EUR) bet-at-home.com reached an increase of 53 %.

At the end of the reporting period of H1 2008 the turnover has respectively grown by 39,3 % (326,2 Mio. EUR) compared to H1 2007 (234,2 Mio. EUR).

The dynamic raise in the amount of customers continued in the second Quarter of 2008. This way the number of registered customers increased by 65 % and reached 1.320.000 (Q2 2007: 800.000).
